(57) **CLAIM**

I claim the ornamental design for a Christmas tree watering device, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a Christmas tree watering device showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side, elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.
